- NOP memo to certifiers re: container production. The group discussed the NOP memo
 regarding certification of container growing systems. Subcommittee members noted the memo
 raised a lot of questions and uncertainty in the certifier community. In addition to feedback
 from the NOSB during the last Executive call, a member noted that the NOP has also heard from
 several other stakeholder groups, such as certifiers, and the International Organic Inspectors
 Association (IOIA).
- The group discussed the need for definitive and quick answers from the NOP to resolve certifier questions and discrepancies. Members shared their perspectives that it can be problematic to certifiers and the operations to not have a quick and decisive answer, and it ultimately stifles the growth of the organic industry. A member added that the absence of an answer often results in conflict and division in the community. There is great interest in continuous improvement and accountability, and the CACS would like to explore how to get involved. The CACS discussed several ways to engage and is considering a request for a work agenda item. SR will develop a draft request.
- Fraud, Traceability and the unique considerations of the fresh product trade. Deferred to next call due to lack of time.

- The CACS Chair summarized the top three topics from public comments: Stop-sale, for which the NOP doesn't have authority; uncertified handlers, because there is no traceability; and acreage reporting. A member asked about areas where the NOSB could provide input while waiting for requests from the NOP.
- A member noted there are a couple of minor areas with regard to certification that could be useful. For example, tightening up certification systems which helps the accreditation aspect. A member noted that there is a gap - not in the system but in the implementation, adding that audits and accreditation oversight often involve checking boxes as apposed to assessing whether or not an operation made a good decision.
- A member indicated the NOP is working on a project regarding fraud that they will ask
 the CACS to work on. MA will follow up with the Deputy Administrator and the
 Director/or Assistant director of AIA to see if they can provide additional information.
 The Subcommittee also discussed checklist-based oversight (as opposed to process-based decisions), which doesn't offer much helpful feedback or oversight about decision
 making. The CACS Vice-Chair suggested they review the comments and use those to
 inform their work going forward.
