## Types of Purchases

#### **Entitlement Program Purchases**

- Largely based on nutrition program recipient demand
- Procurement agent for USDA's Food and Nutrition Service (FNS)
- Relatively consistent year-to-year



## Types of Purchases

#### **Section 32**

- Clause 2 of Section 32 of the Act of August 24, 1935: "encourage the domestic consumption"
- AMS analyzes market conditions and recipient needs "good product at a good price"
- Typically distributed to Food Banks
- Section 32 can not be used for price supported commodities

### Types of Purchases (continued)

#### **Build Back Better (BBB) Initiative**

 Purchases to build food bank capacity and to bridge the gaps for those who face food insecurity – building a better food system

#### **Disaster/Emergency**

Presidentially declared disasters within the United States or its territories

#### **CCC Initiative**

- Purchases made under the authority of Section 5 of the Commodity Credit Corporation Charter Act
- Support food banks and school meal programs during this time of elevated food costs and supply chain challenges
